Booking procedure –

\$250.00 as part payment of charter is required at the time of booking, at least 14 days prior to the charter commencement.

- 2. A cleaning fee will be charged for the vessel being returned in an unreasonable state @ \$50 P/H.
- 3. The cost of any lost or damaged equipment or damaged to vessel may be billed to the hirer.

Charter Fee. –

Cancellations-

Made prior to 30 days of commencement of charter will result in a refund of your deposit less \$75 cancellation fee.
